

## Frequently Asked Questions (FAQs) on the *PRCBC judicial review* decision on Home Office fee for children to register as British citizens

These FAQs have been put together following the decision of the High Court on 19 December 2019 in the case of *PRCBC, A & O v Secretary of State for the Home Department [2019] EWHC 3536 (Admin)*. The information provided here is limited. The case is ongoing. When it is finally decided, it will be possible to consider its wider implications.

### 1) Who and what is the PRCBC case about?

The case was brought by *The Project for the Registration of Children as British Citizens* (PRCBC) to challenge the current fee of £1,012 for each child as unlawfully high.

The case is about children with rights to register as British citizens under the British Nationality Act 1981; and the fee charged by the Home Office for them to register.

### 2) What did the PRCBC case decide?

PRCBC made two legal arguments:

- First, that the law does not allow such a high fee.
- Second, the Home Office acted unlawfully in setting the fee because it did not consider the best interests of the children affected.

The High Court rejected the first argument. It ruled that the [Court of Appeal](#) had previously decided this issue in favour of the Home Office.

But the High Court accepted the second argument. It ruled that the fee of £1,012 charged to children to register as British citizens is unlawful because it has been set by the Home Office without any consideration of the best interests of the children affected.

### 3) What happens next?

The High Court's decision means that the Home Office needs to reconsider the level of the fee for children to register as British citizens.

The High Court has granted the Home Office permission to appeal to the Court of Appeal against its ruling on the second argument.

The High Court allowed PRCBC to try and appeal its ruling on the first argument direct to the Supreme Court. This is unusual. It is known as a '[leapfrog](#)' because it allows PRCBC to 'leapfrog' over the Court of Appeal.

### 4) What can happen at the end of the PRCBC case?

The Court of Appeal or Supreme Court could:

- agree with the High Court judge;
- accept PRCBC's first argument; or
- agree with the Home Office and dismiss PRCBC's case.

**6) I want to register my child as a British citizen. What is the Home Office fee now?**

At this time, the fee remains at £1,012.

**7) Does every child applying to register have to pay the fee?**

No. Children do not have to pay the fee if they would have been born a British citizen had their father been married to their mother at the time of their birth; and their birth was before 1 July 2006. **8) I am a child in local authority care. Do I have to pay the fee to register as a British citizen?**

Yes, unless the exception mentioned above (question 7) applies to you.

**9) I have already registered my child as a British citizen and paid the fee. Will the PRCBC case mean I can get reimbursed?**

PRCBC's judicial review is only about the level of fees. It is not a judicial review about reimbursement. So far, the Home Office has not reduced the fee, let alone agreed to make reimbursements.

**10) Should I now wait to apply for my child to be registered as a British citizen?**

You should get legal advice from a specialist in British citizenship law on your child's individual circumstances. However, it is important for any child with a right to register as a British citizen to register as promptly as possible.

**11) Does the PRCBC case apply to the fee for adults to register as British citizens?**

No. However, if PRCBC appeals successfully to the Supreme Court, this could have some implication for the fee for adult registration.

**12) Does the PRCBC case apply to the fee for adults to naturalise as British citizens?**

No.

**13) What is the difference between registration and naturalisation?**

Registration is the process for all children applying for British citizenship. It is also the process for adults who have a right to register as a British citizen.

Naturalisation is only for adult migrants in the UK applying to become British citizens.

**14) Does the PRCBC case apply to Home Office immigration fees?**

No. Immigration is a separate area of law. More on the distinction between nationality law and immigration law is available from [PRCBC's note](#) about the case.
